- 3. Action Items:
 - 3.1. Approve Minutes from November 23, 2020 EDC Regular Meeting. Motion to Approve: Justin Minzenmayer. Seconded: Gwyn Jordan. Motion Carried: 3-0
 - 3.2. Approve November, 2020 Financial Report. Motion to Approve: Gwyn Jordan. Seconded: Justin Minzenmayer. Motion Carried: 3-0
 - 3.3. Approve December, 2020 Financial Report. Motion to Approve: Gwyn Jordan. Seconded: Justin Minzenmayer. Motion Carried: 3-0 Kelly Selman noted that if we stay around \$9,500 per month in Revenues, we will maintain the EDC Budget for the year.

4. Action Items: BUSINESS OF MEETING

- 4.1. Discuss and consider Tx CDBG Grant that will be utilized for a downtown revitalization program. Mayor Tona Shiplet presented information on the grant and the grant amount of a maximum \$350,000 with a 15% match. This grant is for the Downtown Revitalization Program and will be used to improve or install sidewalks in the downtown area. This is considered the first step in consideration of the grant. After listening to what Mayor Shiplet had to say it was determined that EDC does not have an interest in this sidewalk grant until further information can be provided that includes scope of work and why it is being done. Question from Kelly Selman, is this going to be a good investment considering the building vacancies in the downtown area. Kelly Selman suggested that this item be tabled. Motion to Table: Gwyn Jordan. Seconded: Justin Minzenmayer. Motion Carried: 3-0.
- 4.2. Discuss and consider a contribution to the cost of repairing the roof top at City Hall. Mayor Tona Shiplet presented information on extent of repairs that needed to the City Hall including entire new roof top. EDC question to Mayor is why the city is asking EDC to help pay for this cost when it is considered pure maintenance and should be covered in the City Budget. Mayor Shiplet mentioned the building may be considered for tear down with the extensive repairs needed to the rooftop, HVAC, walls and rewiring needed. Kelly Selman suggested this item will be tabled until an actual cost of repairs is available. Motion to Table: Justin Minzenmayer. Seconded: Gwyn Jordan. Motioned Carried: 3-0.
- 4.3. Discuss and Take Action on Board Member replacement candidate(s) for Mark Kline. Marven Arterberry expressed an interest in joining the board and will be appointed to the EDC Board to finish out the term for Mark Kline. Erick Elwell was also suggested as an alternate candidate for the EDC Board, he will remain on the list if additional replacements are needed. Motion to Approve: Gwyn Jordan. Seconded: Justin Minzenmayer. Motion Carried: 3-0.
- 4.4. Discuss and take action regarding CD at Bancorp South. This CD will not be renewed at this time. Funds will be reinvested after additional information is received. No Action Taken.
