Gov't Code 551.127 (a-l)

\*A member of a governmental body who participates in a meeting as provided by Gov't Code 551.127 (a-l) shall be counted as present at the meeting for all purposes. Gov't Code 551.127 (a-2)

\*A member of a governmental body who participates in a meeting by videoconference call shall be considered absent from any portion of the meeting during which audio or video communication with the member is lost or disconnected. The governmental body may continue the meeting only if a quorum of the body remains present at the meeting location. Gov't Code 551.127 (a-3)

\*Pursuant to Gov't Code 551.127 (e), a quorum of the governmental body will be physically present and the member of the governmental body presiding over the meeting will be present at 111 W. Grand, Whitewright, Texas.
