## 4. NOTICE OF PUBLIC HEARING ON BUDGET

The City Council for the City of Whitewright, Texas will hold one public hearing on the 2022-2023 Fiscal Budget of the City of Whitewright, Texas (Budget) on Thursday, September 15, 2022 at 6:30 p.m. in the Whitewright Visitors Center located at 111 W. Grand Ave in Whitewright, Texas. The meeting will be held for the purpose of receiving community input on the Budget, which will cover the Fiscal Year beginning October 1, 2022 and ending September 30, 2023.

## THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$79.117. WHICH IS A 13.51 PERCENT INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$31,747.

All citizens or interested persons are encouraged to attend these hearings and present their view to the City Council. All citizens are interested persons shall be given an opportunity to be heard for or against any item or amount of any item contained in the proposed Budget. City Hall is accessible to the disabled.
