## **PUBLIC HEARING**

The City Council of the City of Whitewright proposes an increase total tax revenues from properties on the tax roll in the preceding tax year by 5.75 percent (percentage by which proposed tax rate exceeds lower of rollback tax rate or effective tax calculated under Chapter 26, Tax Code). Your individual taxes may increase at a greater or lesser rate, or even decrease, depending on the change in the taxable value of your property in relation to the change in taxable value of all other property and the tax rate that is adopted.

The average taxable value of a residence homestead in CITY OF WHITEWRIGHT last year was \$67,071. Based on last year's tax rate of \$0.728139 per \$100 of taxable value, the amount of taxes imposed last year on the average home was \$488.37. The average taxable value of a residence homestead in CITY OF WHITEWRIGHT last year is \$66,50l. If the governing body adopts the effective tax rate of this year of \$0.699775 per \$100 of taxable value, the amount of taxes imposed this year on the average home would be \$465.36.

If the governing body adopts the proposed tax rate of \$0.740000 per \$100 of the taxable value, the amount of taxes imposed this year on the average home would be \$492.11.
