PROPOSED BUDGET FOR 2015-2016
The City Council for the City of Whitewright, Texas will hold one public hearing on the 2015-2016 Fiscal Budget of the City of Whitewright, Texas on Tuesday, September 8th, 2014 at 5:30 p.m. in the Whitewright Visitors Center located at 111 W . ## PROPOSED TAX RATE

A tax rate of $\$ 0.740000$ per $\$ 100$ valuation has been proposed for adoption by the governing body of City of Whitewright. This exceeds the lower of the effective or rollback tax rate, and state law requires two public hearings be held by the governing body before adopting the proposed tax rate. The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue from the same properties in both the 2014 tax year and the 2015 tax year.
